Description

Course Description:

This course steps students through the construction of a professional portfolio that highlights major skills gained through their academic course work. The professional digital portfolio will be built using portfolio software and will include both scholarly work and writing geared towards the general audience. The final course output may include the digital portfolio, discipline relevant blog articles, and an oral defense of the portfolio presented to an audience of faculty and peers. NOTE: This is intended to be the final course in the degree program. Students must have a 3.0 GPA to enroll. This course is 8 weeks in length.

Course Scope:

This course will serve as one pathway in the culmination of the MS Environmental Policy and Management program, and will result in the production of a professional digital portfolio that showcases concepts mastered throughout the course of study. For each core course in the program and within the student's concentration, the student will revise and improve assignments and prepare them for inclusion in the portfolio. The student will develop introduction materials in a blog like format to describe each item filed in the portfolio and apply creative design to enhance presentation and delivery of the portfolio to future employers. The development of the portfolio may include an oral defense of the materials included within the portfolio hosted by peers and faculty demonstrating student mastery within the field of environmental policy and management.
